As well you can reach out to valuable life members, those on our Diocesan committee and members in your own councils who have worked successfully on resolutions. Attend resolutions dialogue at conventions and AMMs.

Key points were identified at the National AMM of what challenges may be faced when creating a resolution. Below is a list of those challenges and the resources created to help make the important task easier.

Resolved and Bridging Clauses direct the action and final designation:

-required wording *Resolutions Handbook*, the Resolutions Guide and the Resolutions Workshop.

(Resource Manual 618) (Resource Manual 620)

(Resource Presentation 833 A&B)

- the focus of your action must be determined and be in line with the appropriate level of government and League. Ex. Federal Government, National

-resources to be consulted if making changes at a federal level a change an aspect of the Criminal Code or the Canada Health Act, the request must comply with the Canadian Charter of Rights and Freedoms

Constructing the Brief and References contains the argument for the resolutions importance, necessity, factual information to support intent.

Is a reference credible? How do I write a brief, cite it? Is there a handy checklist?
